## 1. INTRODUCTION

---

The purpose of the deliverable is to showcase the Export Pool that InnoBuyer has mapped to support its challengers in the formation of ToR following the pilot period. In total the Expert Pool has 54 experts and each Challenger's country is represented. The expert pool will be made available to InnoBuyer Challengers upon request, and through the InnoBuyer newsletter with consent of the expert organisations.

## 2. METHODOLOGY

---

### 2.1 ELIGIBILITY CRITERIA

---

To ensure the experts can deliver the required value to the Challengers, the Consortium have used a set of quality requirements. As outlined in the Grant Agreement, experts must demonstrate a thorough understanding of public procurement regulations, the legal frameworks governing intellectual property, and the specific challenges of innovation procurement in the public and private sectors – as well as be available to InnoBuyer projects upon relatively short notice. These have been verified through the consortiums previous interactions, published case studies, client portfolio and testimonials, LinkedIn/external links, and specific mentions of relevant procurement and IP legislation.

#### 2.1.1 Additional location considerations

---

In order to increase availability and relevance of the experts, the InnoBuyer consortium has looked at the distribution of projects per country. From Table 1 it can be seen which countries needed at least one representative, and that Spain should have more to remain accessible. Germany is overrepresented in the expert group because a lot of experts have premises and expertise there.
